Defibrillator, agreed in principle for one to be placed in a central location in the village, exact location to be determined.

#### **Planning Applications to be minuted:**

PL/2025/09455 – Ivy Farm West Yatton - Formation of new outdoor equestrian arena with associated fencing for private use – No Objection

#### **Planning Applications considered:**

PL/2025/03672 – Land East of Biddestone Lane – 55 Dwellings (resubmission), Councillors objections remain, the submission of revised plans has not addressed the issues previously raised. Clerk to circulate the Parish Council's response.

It was noted that whilst Highways Officers have not expressed concerns regarding the A420/Biddestone Lane junction in discussion with the applicant, their colleagues within the same department via LHFIG have noted that improvements need to be made to the junction due to the number of traffic collisions.

Councillors agreed that Clerk should raise the issue of how collisions are recorded with Dr Roz Savage MP.

Three Freedom of Information requests have been submitted to obtain further information:

Wiltshire Police - the number of times Police have attended traffic collisions at the A420-Biddestone Lane crossroads during last five years. Response received that non injury incidents are not recorded, injury incidents recorded were two in 2021 & three in 2022, none since.

Wiltshire Council – number of times during last five years street furniture at said crossroads has been repaired/replaced, response outstanding.

Wiltshire Council – sites considered in the local area during the preparation of the local plan and reasons why they were discounted, response outstanding.

Request for a traffic survey (metro count) to be undertaken in Biddestone Lane on section between pinch point & Combe View.

## **Planning Applications recently determined by Wiltshire Council:**

PL/2025/05870 – Littlemead Farm - Redesign of existing dwelling to add first floor in roof space & single storey extension along with internal alterations. Amendment to scheme previously approved PL/2024/02536.

PL/2025/09198 – The Book House – Tree work in conservation area – No Objection
